## **GWYNEDD COUNCIL MATTERS**

The following report was received from Cllr. Annwen Hughes. Cllr. Annwen Hughes reported that since the last meeting that she had been made aware that vandalism had taken place once again in the toilets near the Queens Hotel and this matter is on the agenda to discuss later on. Also had been made aware that a builder has been appointed to carry out the work on the Min y Don public toilets and these toilets will have to be closed whilst this work is done. Had received several complaints that the rubbish bin that was in the corncer in front of the former HSBC bank had been taken away and that she had contacted Gwynedd Council with regards to this and had been

informed that a new bin will be placed there. Also she had asked for the waiting sign that was on the side of the road below the Church to be put back and had been informed that this matter had been forwarded to the Transport Department in Caernarfon. She was disappointed that someone had been posting stickers on the outside of the noticeboard by Morfa Stores and she had been cleaaning these off as it was not possible to read the notices inside Cllr, Gwynfor Owen apologized for not being present at the last Council meeting due to illness, but that several local residents had contacted him during the past month. He had been visiting the new housing estate and meeting with some of the new tenants. He expressed concern that the toilets near the Queens Hotel were being vandalized, disappointment that the report into Neil Foden's procedures had not been published, that Gwynedd Council had been notified of this at very short notice, and that the Welsh Safeguarding Board had held back the report without any explanation. The Welsh Government is looking at changing the structure of the Fire Authority, and this will be discussed in a Fire Authority meeting on the 20th of this month.

## **MATTERS ARISING**

#### **Budget Plan**

It was reported that the Council had spent £22,036.79 (which included bank charges) since the start of the new financial year and this was £35,729.46 less expenditure than what was earmarked in the budget for the 2025/26 year.

## **Christmas 2025**

Cllrs. Simon Turner and Mark Lewis gave the following report regarding the christmas festivities - Christmas 2025 planning is well underway with late night opening (shops and cafés), Christmas festivities, and a lantern parade (led by Santa Claus) on the evening of Saturday 29th November.

So far, financial donations for new LED Light Strings have been received from Shell Island, Menai Heating, Middleton Foods, Rock Ardudwy, Peninsula Home Improvements, and Caffi Castell. Gwynedd County Highways Department have given permission this year for the new LED lights to be hung across the High Street. As with previous years, Christmas lights will also be placed on street lighting poles in the Town.

Cadw have kindly agreed that the Castle Car Park can be closed to public parking so this area will used for the public gathering with a celebrity guest turning on the lights. Carol singing will also take place in the Car Park. Rock Ardudwy have kindly agreed to provide a stage, marquee and sound system for the evening in the car park. Harlech Primary School children are taking part in a competition to design a poster which will be used to publicise the event on Social Media and in printed flyers. This year there will be fabulous family orientated prizes awarded for the best lanterns in the parade. So far, these prizes have been donated by Caffi Llew Glas, Caddy Café, Hufenfa'r Castell, Castle Hair Studio, The Ship Aground, RED Performance, The Pit Stop Food Bar, Caffi Castell, Bay View Restaurant, Y Gwyllt Snowdonia Wilderness Café, Cae Du Designs, North Wales Sauna Company, Morfa Garage, and Bean & Blŵm.

# **Training Courses for Members and Clerk**

The Clerk reported that she had received an e-mail from One Voice Wales outlining the training courses that were available between June and September and that she had forwarded this already to all Members. The Clerk stated further that Cllr.
